

### The Right to a Fair Trial

If we do not use something, we typically forget we have it. As U.S. citizens, we have the right to a fair trial. This means a speedy and public trial by an impartial jury with the aid of professional council. Most of us have never and hopefully will never use this right, but it is there if we need it.

Four years ago, in North Carolina, a judge ruled that a man, who was convicted of murder as a teenager and was imprisoned 28 years ago, did not receive a fair trial and could go free. The judge determined there was not enough evidence to justify the man's conviction for a 1988 murder.

Reviewing this today proves to be irritating. It is incredibly ridiculous how a man could spend over half of his life in prison and be released 28 years later because his trial was deemed to be unfair. The man's lawyer told reporters, "... he was hyperventilating as he realized he was about to be freed." What a tragedy.

Yet, when we turn to the Bible, we see a completely innocent man, who did not receive a fair trial, condemned to death in a rigged and illegal trial set up by those who hated Him. Thankfully, this was all according to the plan of God to bring us the way to be saved.
